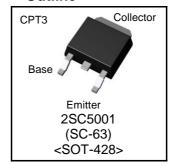

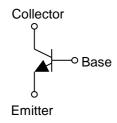

Fig.1 Ground Emitter Propagation Characteristics

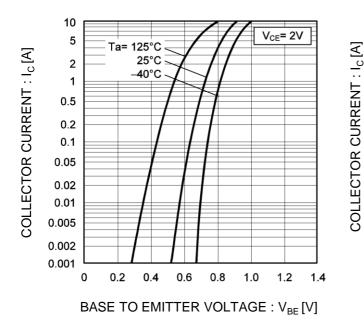
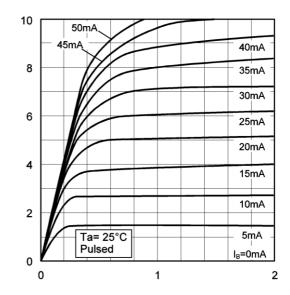


Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current(I)

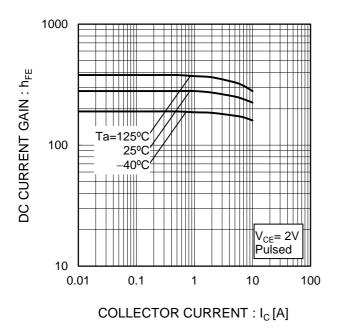
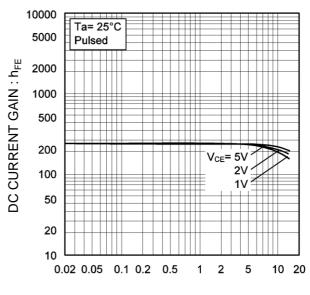


Fig.4 DC current gain vs. output current (II)

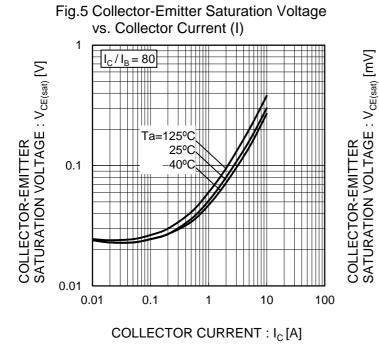
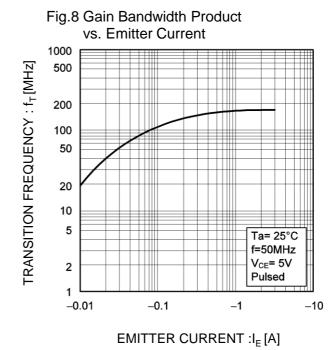


Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II) 1000 Ta=25°C 500 200 100 $I_{\rm C}/I_{\rm B} = 80$ 50 50 20 10 5 2 0.01 0.02 0.05 0.1 0.2 0.5 10 20 COLLECTOR CURRENT : I_C[A]

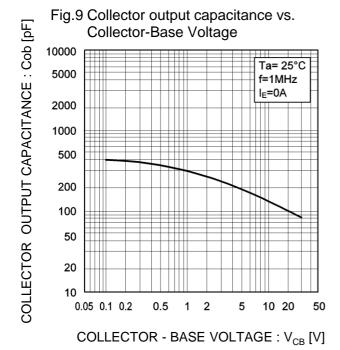
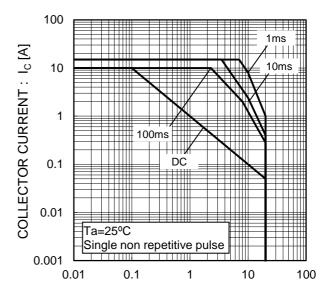
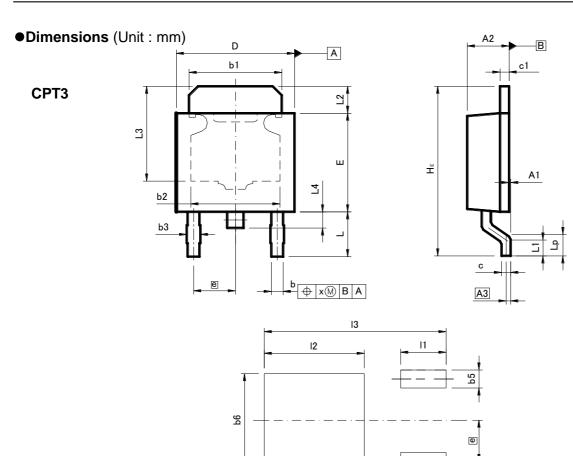


Fig.10 Safe Operating Area
