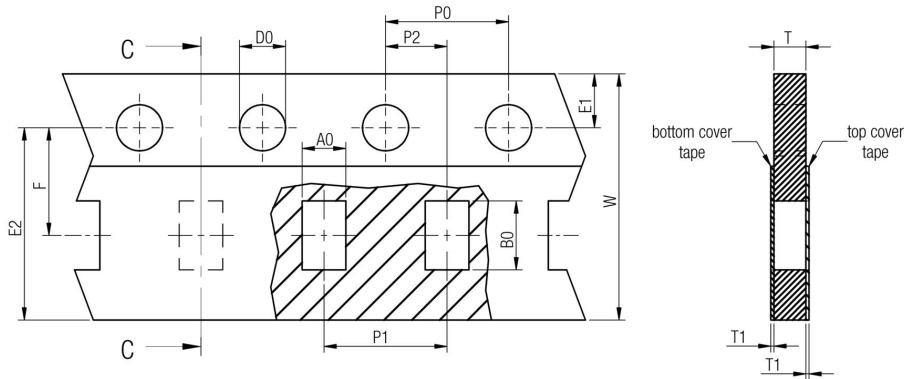
F Derating Curve:



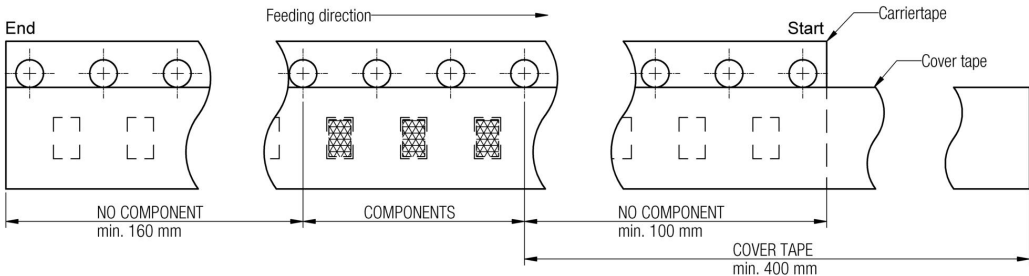
