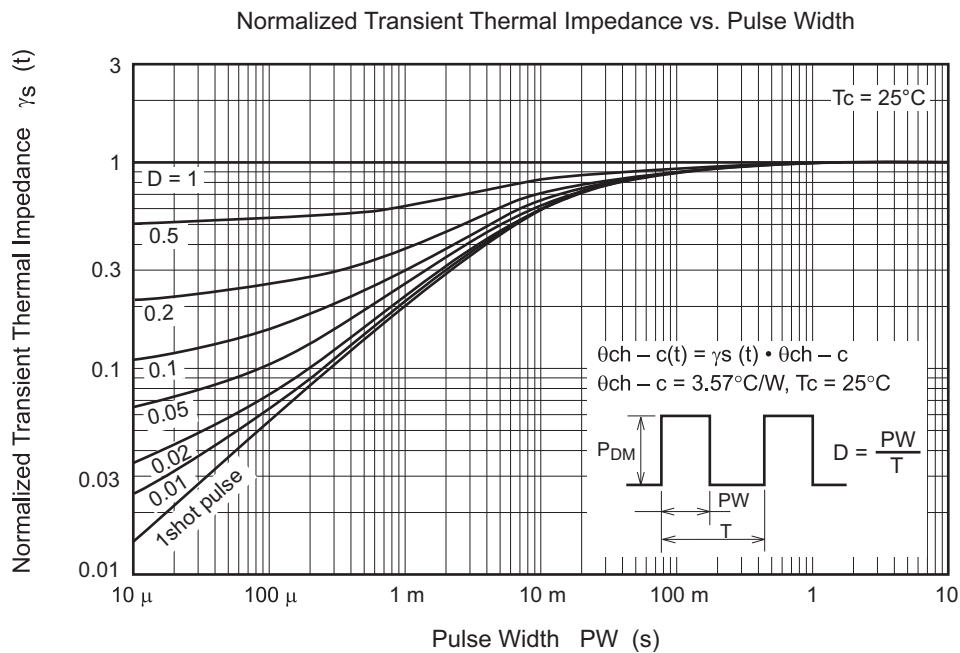

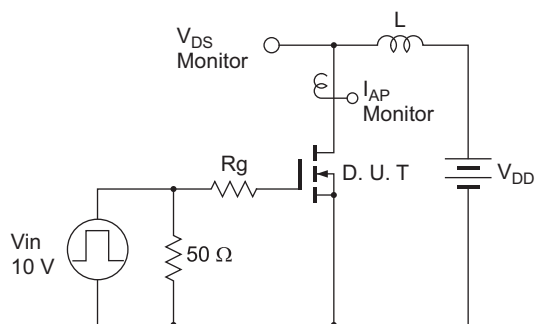
Static Drain to Source On State Resistance

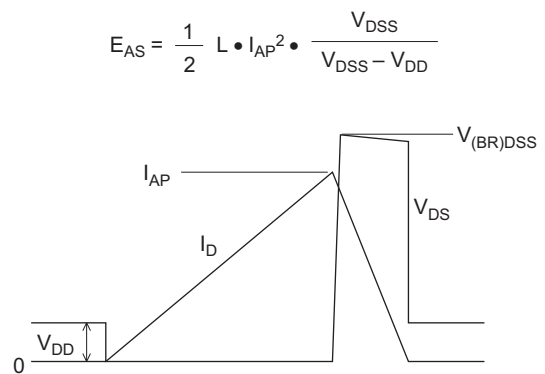
Reverse Drain Current vs.

Channel Temperature Derating



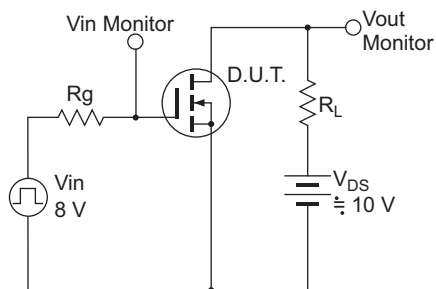
Avalanche Test Circuit



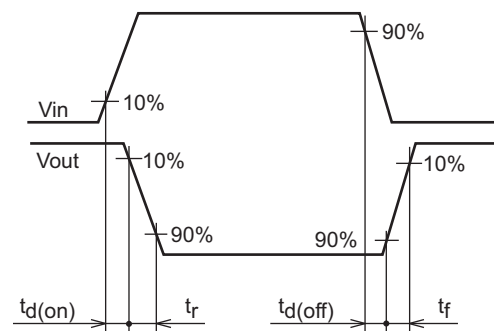
Avalanche Waveform



Switching Time Test Circuit



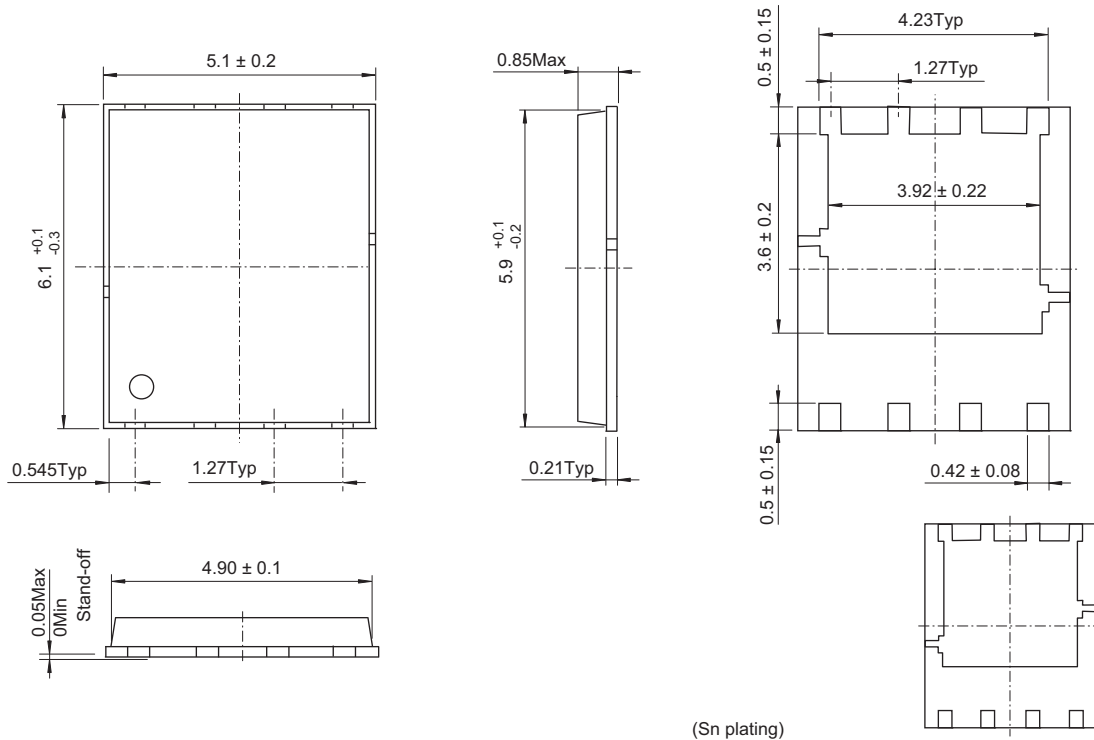
Switching Time Waveform
